## Terms and Conditions

**Effective Date:** 1st January 2025

Welcome to Mogwai Media Weddings, a division of Mogwai Media Ltd dedicated to providing wedding photography and related creative services. By accessing or using our services via [www.mogwaimediaweddings.co.uk](http://www.mogwaimediaweddings.co.uk), you agree to the following terms and conditions. If you do not agree, please refrain from using our services.

### 1. Definitions

- 1.1. **"Services"** refers to wedding photography, pre-wedding consultations, editing, albums, and other related services offered by Mogwai Media Weddings.
- 1.2. **"Client"** refers to any individual, couple, or organisation engaging with our wedding services.
- 1.3. **"Final Deliverables"** refers to the final edited photographs, or products delivered as part of the agreed-upon services.

### 2. Services

- 2.1. **Scope of Work:** A detailed agreement or proposal outlining the scope of services will be provided before work begins. Changes to the scope may incur additional fees.
- 2.2. **Revisions:** Each package includes a number of edits or revisions. Additional changes will be charged at our standard hourly rate.
- 2.3. **Event Date:** The Client is responsible for confirming event details, such as date, time, and location, in writing. Changes may affect availability and pricing.
- 2.4. **Weather and Venue Conditions:** Mogwai Media Weddings will make reasonable efforts to accommodate challenges such as adverse weather or venue restrictions but cannot guarantee specific results under such circumstances.

### 3. Payments

- 3.1. **Fees and Deposits:** A non-refundable deposit of 20% is required to secure the booking. The balance must be paid by 30 days before the event date.
- 3.2. **Payment Terms:** Payments must be made as per the schedule outlined in the agreement.
- 3.3. **Late Payments:** Late payments may result in delays in services or deliverables and may incur additional fees.
- 3.4. **Cancellation Policy:** In the event of cancellation, the deposit will not be refunded.

### 4. Client Responsibilities

- 4.1. **Access:** The Client must ensure the photographer has adequate access to the venue and are informed of any restrictions.
- 4.2. **Timelines:** The Client must provide an accurate schedule of the event to ensure all moments are captured.
- 4.3. **Collaborative Efforts:** It is the Client's responsibility to inform family, guests, or venue staff of our involvement and ensure cooperation during the event.

## 5. Intellectual Property

5.1. **Ownership:** Mogwai Media Weddings retains the copyright to all photographs and videos created.

5.2. **Usage License:** The Client will receive a license to use the final deliverables for personal purposes, including printing and sharing on social media. Commercial use is not permitted without prior consent.

5.3. **Portfolio Use:** Mogwai Media Weddings reserves the right to use final deliverables for promotional purposes, including but not limited to portfolios, websites, and social media. Clients may request exceptions in writing.

## 6. Deliverables

6.1. **Delivery Timeline:** Final deliverables will be provided within 6-8 weeks after the event unless otherwise specified.

6.2. **Format:** Deliverables will be provided in the agreed-upon format, such as digital files or printed albums.

6.3. **Backup Policy:** Mogwai Media Weddings will store backups of deliverables for 12 months. After this period, backups may no longer be available.

## 7. Liability and Indemnity

7.1. **Limitation of Liability:** Mogwai Media Weddings is not liable for unforeseen circumstances, including equipment failure, natural disasters, or emergencies that prevent us from fulfilling our obligations. Liability is limited to fees paid by the Client.

7.2. **Indemnity:** The Client agrees to indemnify and hold Mogwai Media Weddings harmless against claims, damages, or expenses arising from the use of our services.

8.1. Either party may terminate the agreement with written notice of 30 days.

8.2. **Termination Fees:** Fees for work completed up to the termination date remain payable by the Client.
